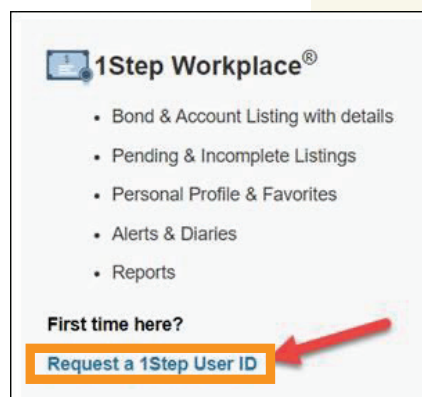
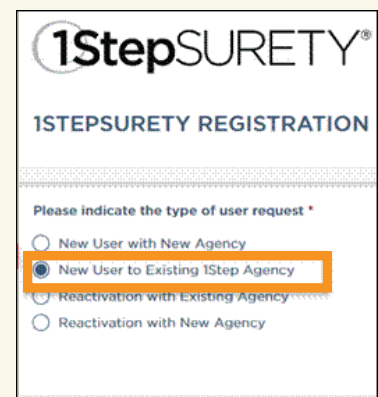
To access policy documents, you must be registered for both EBC and 1StepSurety.

For EBC registration, go to [Electronic Business Center](#), click **How to Register**, create a User ID, then click **Register Account**.





For 1StepSurety, visit [1StepSurety Registration](#), click **Request a 1Step User ID**, choose **New User to Existing 1Step Agency**, then follow the prompts.


HOW TO PULL POLICY DOCUMENTS

1. Log in to 1StepSurety.
2. On the home page enter the Bond Number for the policy documents you wish to pull. Click **Go**.
